Exhibition Dates: June 18-29, 2025

Entry Fee: \$25 per entry (limit of three entries)

ENTRIES CLOSE – May 31, 2025

Prizes:

- First Prize; \$1,000 & 2 weeks free Timbermill Gallery hire
- Highly Commended; \$500
- Curator's Choice; \$200 & Art Pack
- People's Choice; Art Pack

By forwarding a completed submission form, the artist agrees to accept the terms and conditions outlined below, and that submission details are correct. The organisers retain discretion of assessment of artist or artwork in meeting the terms and conditions of entry. The organisers also reserve the right to revoke/re-award prizes if the finalist provides false information.

Selection of works:

The successful entries (finalists) for the prize are selected by the organisers, and the prize winners are selected by a panel of local artists and dignitaries. The People's Choice is selected by members of the public attending the opening night.

Prize winners will be announced at the opening night and published on the Alison K Lawther Artist Studio and Timbermill Gallery website and social media pages. The judges' decision is final, and no correspondence shall be entered into.

Artists will be asked to provide additional information (such as biographical details and a statement about the work) to assist with preparation of prize-related material.

Entry Terms and Conditions:

- The artist grants Alison K Lawther Artist Studio and Timbermill Gallery permission to display their entered artwork.
- Artworks must have been completed within the past 18 months.
- Artworks must be original. The artist warrants that the work is their original work and does not infringe the copyright, moral rights or other rights of any third party.
- Must be a painting, may be in any medium (e.g. oil, acrylic, watercolour, mixed media).
- Maximum size: 105cm high x 105cm wide (including frame).
- Works must have suitable D-rings and wire/strings and be ready for hanging.
- Artist's name, contact details and title of work must be on the back of artwork.
- A 30% commission shall apply to sale of artworks.
- Artwork must stay at Timbermill Gallery for the duration of the Exhibition.
- It is expected that the Artist will contribute to opening night by attending, inviting clients, friends and family.
- Collection of artworks, by purchasers or artists shall take place on 29 June 2025 by 4.00pm (non-collection fee of \$5 per day will apply).

Key dates and information:

- Entry Fee: \$25 per entry, maximum of three entries per artist
- Submissions: Close May 31, 2025
- Successful entries: Finalists will be advised by June 6, 2025
- Artwork drop-off: 10.00-2.00, June 16, 2025
- Exhibition dates: June 18-29, 2025
- Opening night: Saturday 21, June 2025
- Artworks collected: 2.00-4.00, Sunday 29, June 2025
- Winners announced at opening night.
